## Introduction:

This draft statement sets out the school's arrangements for managing the access of providers to pupils at the school for the purpose of giving them information about the provider's education or training offer. This complies with the school's legal obligations under Section 42B of the Education Act 1997, the new statutory guidance 1<sup>st</sup> September 2022 and the amendment to the Skills Bill updating Provider Access Legislation from January 2023

## Pupil entitlement

All pupils in years 7-11 are entitled:

- To find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point;
- To provide at least four encounters with providers of approved technical education qualifications or apprenticeships, two in years 8/9 and two in years 10/11.
  - To hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships – through school activities and meetings, group discussions and taster events;
- To understand how to make applications for the full range of academic and technical courses at colleges and other providers. This can include A Levels, T levels and Vocational Qualifications.

The School will work with an independent Careers Information and Guidance Service (Careers South West) to provide advice on all career and education options and pathways
